The vendor table options are as follows:

- Indoors: 4' shared (1/2 of 8' table) - \$50 (includes 1 meal ticket)
- Outdoors: 6' table - \$50 (includes 1 meal ticket)

Electricity is available; we suggest bringing an extension cord. All extension cords must be taped down to the floor.

Vendors are strongly encouraged to bring a door prize to collect names and contact information at their table for follow-up.

**NOTE: Only one table is available per business. GAWN reserves the right to limit the number of businesses to two per industry and will be determined on a first come/first serve basis (first applied and paid). Vendors and sponsors must be present and staff their table.**
